**CITY OF QUESNEL  
BYLAW NO. 1774**

**A Bylaw to enforce designated bylaws of the City.**

---

**WHEREAS**, pursuant to section 264 of the *Community Charter*, Council may, by bylaw:

- (a) designate those bylaws that may be enforced by means of a form of ticket prescribed by regulation;
- (b) designate a person or class of persons as a bylaw enforcement officer; and,
- (c) authorize the use of any word or expression on a ticket issued to designate an offence against a bylaw;

**AND WHEREAS**, pursuant to section 265, Council may establish:

- (a) one or more penalties, in terms of fines, not greater than the amount prescribed by regulation to an offence; and,
- (b) different fine amounts that apply depending on whether the amount is paid on or before the 30<sup>th</sup> day from the date the ticket is served, or paid after such date.

**AND WHEREAS**, Council deems it desirable to adopt a bylaw for such purposes;

**NOW THEREFORE** the Council of the Corporation of the City of Quesnel in an open meeting assembled enacts as follows:

**PART I – BYLAW ENFORCEMENT**

1. This bylaw may be cited as “City of Quesnel Municipal Ticket Information Bylaw No. 1774 of 2015.”
2. The schedules attached hereto are deemed to be a part of and forming this bylaw.
3. The bylaws listed in Column 1 of Schedule 1, as amended or repealed, are hereby designated as bylaws which may be enforced by means of a municipal ticket in the form prescribed by provincial regulation.
4. Those persons listed under Column 2 of Schedule 1, as amended or repealed from time to time, are hereby designated as Bylaw enforcement Officers for the purpose of enforcing those bylaws listed in Column 1 opposite to the respective title of such persons, and includes the successors and delegates of those positions.

5. The words or expressions set forth in Column 1 of Schedules 2 through 9 to this bylaw hereby designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words of such expressions.
6. The amounts appearing in Column 3, titled "Fine", of Schedules 2 through 9, if provided for, are hereby designated as the applicable fines for offences listed under column one opposite the fine
7. The Corporate Officer is hereby empowered to do all things necessary to give effect to this bylaw.

## **PART II – BYLAW AMENDMENTS**

8. City of Quesnel Nuisance Bylaw No. 1456 is hereby amended by:
  - (a) removing section 6.3 and replacing with:
    - 6.3 On being convicted of an offence under this bylaw, a person is liable to pay a fine of up to \$10,000, the costs of prosecution, and compensation for any loss or damages resulting from the offence
  - (b) by adding section 6.4:
    - 6.4 This Bylaw may be enforced:
      - (a) by means of a ticket in the form prescribed for the purpose under the *Community Charter*, and fines of up to \$1,000 imposed for offences under the *City of Quesnel Municipal Ticketing Information Bylaw 1774, 2015*;
      - (b) by proceedings brought under the *Offence Act*; or
      - (c) by any other proceedings authorized by law.
  - (c) repealing Schedule "A".
9. Animal, Bird and Insect Control and Licensing Bylaw No. 1700 is hereby amended by:
  - (a) repealing from Section 17.5 (b) the words "Schedule "B"" and replacing them with "Schedule A"
  - b) payment of the impoundment and boarding fees, costs and fine charges incurred in respect of the seizure and boarding of the animal as set out in Schedule A

- (b) repealing sections 19.3, 19.4 and 19.5.
- (c) repealing and replacing Section 20.1 with “Schedule “A” is attached to and forms a part of this Bylaw”, to be read as:

20.1 Schedule “A” is attached to and forms a part of this Bylaw.

- (d) repealing Schedule “B”.

10. City of Quesnel Business Regulation and Licencing Bylaw No. 1684 of 2010 is hereby amended by:

- (a) repealing from section 6.1(a) the words “M.T.I. Bylaw No. 1320, 1995” and replacing them with the words “*City of Quesnel Municipal Ticket Information Bylaw No. 1774 of 2015*” to be read as:

6.1(a) by means of a ticket issued under the *City of Quesnel Municipal Ticket Information Bylaw No. 1774 of 2015*.

- (b) repealing from section 6.3 (a) the words “M.T.I. Bylaw No. 1320, 1995” and replacing them with the words “*City of Quesnel Municipal Ticket Information Bylaw No. 1774 of 2015*” to be read as:

6.3(a) if issued a ticket, to pay a fine imposed under the *City of Quesnel Municipal Ticket Information Bylaw No. 1774 of 2015*.

### **PART III – INTERPRETATION**

11. If any part, section or phrase is held to be of no force or effect by a court of competent jurisdiction, that part, section or phrase shall be struck out from this bylaw and the remainder shall be considered to have been adopted without those parts, sections or phrases thereto.

12. M.T.I. Bylaw No. 1320 of 1995, M.T.I. Bylaw Amendment Bylaw No. 1360 of 1996 and any amended schedules are hereby repealed in their entirety.

READ A FIRST TIME this 5<sup>th</sup> day of October, 2015.

READ A SECOND TIME this 5<sup>th</sup> day of October, 2015.

READ A THIRD TIME this 19<sup>th</sup> day of October, 2015.
