BUSINESS FAÇADE IMPROVEMENT PROGRAM

This program provides grants to property and business owners to renovate, restore, or redesign retail and commercial building facades and storefronts in Quesnel.

The goal of the Quesnel Façade Improvement Program is to encourage owners or commercial tenants to invest in building façade upgrades that create a more interesting and appealing streetscape, attracting customers, clients, visitors and businesses to the commercial areas of town. The program promotes private sector investment, increases assessed property values, and stimulates the local economy. Façade improvements also help building owners attract and retain commercial tenants, and promote the marketability of retail and commercial businesses.

Eligible façade improvements may include: new lighting, exterior architectural features, new windows, facade painting, new siding, entrances and doorways, and awnings.

The City of Quesnel will provide a 50% reimbursement grant up to a maximum of \$5,000 per building/project to improve the facades of eligible commercial buildings. Minimum project value is \$2000. The application is easy, usually with a quick approval timeline.



Work BC assists all persons to meet their employment-related goals and achieve increased independence and self-reliance. They offer a free service for job postings, which are emailed to a client list and posted on their job board and social media platforms.

Work BC offers a meeting room space for information sessions to attract new employees and to conduct interviews. They also accept resumes to support recruitment for businesses.

Each year, Work BC holds a Job Fair, where employers have the opportunity to collect resumes and meet potential employees as well as network with other businesses.

WAGE SUBSIDY PROGRAM

This program provides temporary financial assistance to employers in the form of a wage subsidy, if they agree to hire a participant for at least 35 hours/week for 12 to 24 weeks. Up to 50% of the wage can be provided during that period.

UNPAID WORK PLACEMENTS

Clients who meet certain qualifications are eligible for short-term placements with employers, giving employers an opportunity to evaluate potential employees and make sure an individual would be a good fit.

Northern Development Initiative Trust is a regionally operated economic development funding corporation for central and northern British Columbia. Northern Development operates independently from government and provides the funding and ability to identify and pursue new opportunities for stimulating economic growth and job creation within the region. Northern Development offers a range of funding programs suited to a diverse set of economic development priorities in central and northern British Columbia.

COMPETITIVENESS CONSULTING REBATE PROGRAM

This program provides a rebate to small and medium sized companies engaged in manufacturing, innovative technologies, resource processing, transportation, distribution and their first line suppliers for external consulting services. A rebate of up to 50% to a yearly maximum of \$30,000 can be recovered for the cost of external business consulting projects. Projects must focus on increased productivity, new or incremental revenues, profitability and/or job creation. Eligible companies must be privately owned, have fewer than 500 employees, revenues less than \$100 million, and be headquartered within the Northern Development Initiative Trust region.

SMALL BUSINESS RECOVERY CONSULTING REBATE (SBR)

In response to the impact the forestry sector downturn and COVID-19 pandemic are having on businesses in central and northern B.C., Northern Development is offering the (SBR) Consulting Rebate program. This program is designed to help businesses reduce the barrier to accessing professional expertise and recover the costs of third-party consulting projects. These types of projects must focus on ways to sustain businesses during the current economic downturn. The SBR Consulting Rebate will reimburse small and medium sized businesses (operators) for contracted consulting services. Eligible companies must be privately owned, have fewer than 500 employees, revenues less than \$100 million, and be headquartered within the Northern Development Initiative Trust region.

NORTHERN INDUSTRIES INNOVATION FUND (NIIF)

The NIIF program provides funding for small and medium sized businesses in eligible industries for applied research and development, new or improved products, and services and testing of innovative equipment or technologies to support capital investment decisions. This program offers a rebate of up to 50% to a maximum of \$50,000 per project. Eligible companies must be privately owned, have fewer than 500 employees, revenues less than \$100 million, and be headquartered within the Northern Development Initiative Trust region.

B.C.'s Employee Share Ownership Program provides employees with a 20% tax credit for making investments in their employers' businesses. In most cases, investments can be made from or transferred to self-directed RRSPs, which can result in further tax benefits. The program also shares the costs of setting up a plan. The program is available to both privately held and publicly traded companies.

Small Business Venture Capital Tax Credit

The Small Business Capital Tax Credit is for corporations that invest in shares of a registered venture capital corporation or eligible business corporation. By making an equity capital investment in B.C. small businesses, investors will receive a 30% tax credit.

Tax credits for hiring apprentices

The Provincial and Federal governments will provide income tax credits for employers of apprentices registered in Industry Training Authority apprenticeship programs. As an employer, you are eligible to claim the credit if you're subject to B.C. income tax for the taxation year that the credit is being claimed.

The B.C. Employer Training Grant program (ETG) supports skills training to address provincial labour market needs. The program is delivered by the Province of British Columbia and is funded by the Government of Canada through the Workforce Development Agreement (WDA). The goal of the ETG is to help British Columbians access the skills training needed to adapt to the changing requirements of jobs and the labour market while encouraging employer involvement in the training of their employees. Employers are eligible to receive up to \$300,000 per fiscal year (April 1 – March 31).
